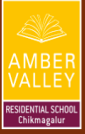

**B FEE RULES REGARDING WITHDRAWAL OF STUDENTS**

**CUT OFF DATES** Pre-Set for FEE collections to enable the school to prepare for the ensuing TERM / YEAR  
**DUE DATES for payment:** **BEFORE 31<sup>ST</sup> MARCH** (1st Instalment), **31st AUGUST** (2nd Instalment)  
**WITHDRAWAL PROCESS** (Also stated in the Student Parent Handbook)

All TC requests must be applied through a duly signed letter in the prescribed format (See Student Parent Handbook)  
 The official date of TC request will be the Date of receipt of the signed hard copy withdrawal letter by the School

**1 WITHDRAWALS AT THE END OF THE ACADEMIC YEAR**

*Full first term fees with applicable penalty should be paid to obtain NO DUE certificate for TC issue for requests received after 28th Feb*

- **Before 31<sup>st</sup> March** - **100%** refund of Fees, charges paid for forthcoming year
- **31<sup>st</sup> Mar to 15<sup>th</sup> Apr** - **50%** refund of Fees, charges paid before due date for the forthcoming year  
*If Fees are paid after due date, fine of Rs. 5,000/- will be charged.*
- **15<sup>th</sup> Apr to 30<sup>th</sup> Apr** - **25%** refund of fees paid by due date for forthcoming year  
*For Fees paid after due date, fine of Rs. 5,000/- will be charged.*
- **After 30<sup>th</sup> April** - **1<sup>st</sup> Term Tuition Fees** for forthcoming year is payable before issue of TC  
*For Fees paid after due date, fine of Rs. 5,000/- will be charged.*

**OUTFITTER CHARGES** 100% chargeable if TC request received before - **31st March**  
**TEXT BOOK CHARGES** 100% chargeable if TC request received before - **31st March**

**2 WITHDRAWALS IN THE MIDDLE OF THE ACADEMIC YEAR**

*Full 2<sup>nd</sup> Term fees with applicable penalty should be paid to obtain NO DUE certificate for TC issue for requests after 31<sup>st</sup> August*  
 There will be no reimbursement of the Fee paid for that term

- **1<sup>st</sup> Sep to 28/29<sup>th</sup> Feb** - **Nil** refund of 2<sup>nd</sup> Instalment Fees if paid by Due Date  
*For Fees paid after due date, fine of Rs. 5,000/- will be charged.*

**TRANSFER CERTIFICATE CAN BE ISSUED ONLY AFTER CLEARANCE OF ALL DUES**
